- Tender form will be issued to contractors and also to their authorized agent / representatives.
- Tender form shall be issued on 24th September, 2019 till 4:00pm and shall be casted in tender box on 25th September, 2020 at 1200 hours and opened on the same day at 1:00pm in the presence of tenderers or their authorized representatives, who may like to be present.
- The tender should be free from cutting and over writing etc.
- The tendered rates shall be valid till the completion work and in no case any escalation shall be admissible on any pretext.
- The conditional tender and tender without call deposit shall not be entertained / considered.
- The successful party / firm shall be execute a contract agreement (at its own expense) with Cantonment Board Abbottabad shall include additional terms / condition and the same shall be binding on both the parties for faithful execution of the contract.

8. The successful party / firm shall deposit annual registration fee / security with Cantonment Board Abbottabad immediately.
9. The quantum of work may vary (upto 10% above) and the successful contractor shall be bound to execute the work as per approved rates of the relevant category.
10. The Cantonment Board Abbottabad will not supply any kind of material and machinery to the contractors.
11. In case the tenders are not receive or rejected due to any administrative reason, the same shall be casted on 28th September, 2020 at 1200 hours at the same venue for which no separate notice shall be required.
12. The payment of the work done bill will be made after the Lab. Test report to be submitted by the contractor on his own expense.
13. The Cantonment Executive Officer / Cantonment Board reserve the right to accept any or reject all tenders under PPRA's Rule No. 33(1).
14. These works are advertised for the purpose of obtaining rates, however its execution will be subject to availability of funds and will be prioritized on need basis.
