**GENERAL TERMS & CONDITIONS:**

- (1) The financial bidding will be online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of ML&C Deptt: i.e. [www.etender.mlc.gov.pk](http://www.etender.mlc.gov.pk)
- (2) E-bidding shall be done on above/ below system in BOQ. All bidders are required to have valid registration with PEC and valid NTN
- (3) The bidder shall submit through Courier / Contractor Representative. 2% bid security sealed in envelop of the estimated cost in shape of call deposit (Original) from scheduled bank before closing date and time.
- (4) The tender shall be cast in electronically on or before 15/02/2021 upto 12:00 hours and shall be opened on the same day at 2:00 PM in the presence of tenderers or their authorized representatives, who may like to present.
- (5) Conditional tender and tender without call deposit shall not be entertained.
- (6) Rates should be submitted on above or below the MES Schedule of Rates, 2014 (as amended upto date).
- (7) Cantonment Board Abbottabad reserves the right to demand the analysis of the quoted rates from the concerned bidder, to check their reasonability and workability.
- (8) In case if the lowest tendered rate is less than reasonable rates, the lowest bidder shall have to deposit Standing Security (refundable after successful completion of the work) @ 12% of the estimated cost in shape of call deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and the tender will be cancelled/re-invited.
- (9) The quoted rates shall be valid till the completion of work and in any case no escalation shall be admissible on any pretext.
- (10) The successful party/firm shall execute a contract agreement (at its own expense) with Cantt Board Abbottabad which shall include additional prescribed terms & conditions and the same shall be binding on both the parties for faithful execution of the contracts.
- (11) Work orders would be issued to only those contractors who entered into an agreement with Cantt Board Abbottabad on the acceptance of offered rates.
- (12) The contractor shall not assign or sublet the contract in any case. If contractor/firm found involved at any stage shall be liable to cancellation of contract at his/their own risk and cost and the already deposited 2% earnest money shall be forfeited. The case for blacklisting of contractor/firm shall also be placed before the Board.
- (13) All Govt. taxes shall be deducted from the bill as per rules.
- (14) Cantonment Board Abbottabad shall not supply any kind of material and machinery to the contractors.
- (15) The successful contractor / firm will have to complete all material / lab tests from University of Engineering & Technology, Taxilla OR Military College of Engineering, (Lab Section), Risalpur Cantt, before processing of bills at his/their own expenses.
- (16) Cantonment Executive Officer/Cantonment Board reserves the right to accept or reject all tenders (prior to approval) as per rule 33(1) of PPRA Rules 2004.
